The medieval papacy grew into a position of immense significance even beyond the frontiers of the Latin world. Millions of documentary texts sent or received by the various curial offices bear witness to the papacy's highly influential role in the cultural, political, and economic evolution of the European continent. This unparalleled source of information has been intensely studied since the late 19th century from different premises and perspectives, and with varying objectives and methods: more frequently on a national basis, rather rarely in a larger comparative manner, either as full-text editions, or as pragmatic calendars and repertories.

For a variety of reasons and despite some isolated institutional or personal endeavours in past decades, Romania – a country inheriting now a rich and diverse historical development on the old frontier line that in the later Middle Ages separated the Catholic and Orthodox areas on the one hand, and the Christian and the Muslim worlds on the other – has not yet been part of the international effort that has exploited the medieval material preserved in the Vatican and Roman archives. At the present time, however, the *Babeş-Bolyai University* in Cluj-Napoca intends to initiate through close international cooperation a research programme with the explicit aim of studying the massive reservoir of historical information left behind by curial registration of the 14th-16th centuries and concerning the Romanian territory. Such an initiative is encouraged both by venerable scholarly enterprises and by recent projects that have brought to light valuable documentation concerning the communication of the Holy See with the various regions of Europe forming the eastern periphery of Latin Christianity, from the Mediterranean up to Scandinavia.
